\*\* Distinguished Professor will be offered only to Senior Professors with outstanding academic achievements and substantial international standing following the 16<sup>th</sup> Governing Body resolution held on 22 January 1998 (Agenda Item 5) and will not be a regular FCS assessment/promotion avenue. This will be considered by the Governing Body on recommendation by the Director on merit of a case.

Keeping in view of the services performed by the Academic staff, all members of the academic staff as proposed above will be covered by the FCS in vogue from time to time.

## **Disciplinary Authority /Appellate Authority**

In cases where the Governing Body is the Appointing Authority, the Chairman, Governing Body will be the Disciplinary Authority. He may delegate the authority to the Director to act as the Disciplinary Authority in a specific case.

Secretary, Department of Science and Technology, Government of India, will be the Appellate Authority.

3. Necessary actions may, accordingly, be taken after following necessary formalities with the West Bengal Registrar of Societies.
