- i. Firms should have relevant experience of having successfully completed re-modification of existing/SITC of new electrical panel boards/APFC panels or any other electrical fabrication works in any of the last seven years ending on 31.03.2021, of minimum single work value not less than Rs.4.49 lakhs or for two similar work value not less than Rs 3.37 lakhs each or for three similar work value not less than Rs.2.24 lakh each. In case the agencies do not have the Completion Certificate, they may submit copy of Work Order with payment certificate or any other proof of payment. The Centre reserves the right to get the authenticity of satisfactory work completion by referring the matter to the issuing authority and if found to be false, the tender will be liable for cancellation even after opening the price bid.
- ii. Firms should have working experience with CPWD / State PWD / MES / Railways / BSNL / Reputed Central or State PSUs /Autonomous Body/Reputed Private Organisations.
- iii. Average annual financial turnover during last 3 (three) years ending 31.03.2021 should be minimum of Rupees 11.0 lakhs by giving a self-certificate. Firms should furnish last three years' IT acknowledgement.
